2. **ARTICLES OF AMENDMENT TO  
FIFTH ARTICLES OF RESTATEMENT OF  
ARTICLES OF INCORPORATION OF  
SEISINT, INC.**

Pursuant to the provisions of the Florida Business Corporation Act, the Fifth Articles of Restatement to Articles of Incorporation of SEISINT, INC. are hereby amended as follows:

1. Article IV, Section 1 of the Fifth Articles of Restatement is hereby amended by deleting the second paragraph in its entirety and replacing it with the following:

"Of the authorized shares of Preferred Stock, 1,878,372 shares shall be designated as "Series A Preferred Stock" and shall have the powers, designations, preferences, rights, qualifications, limitations and restrictions set forth in this Fifth Articles of Restatement (the "Articles")."

3. Except as amended hereby, all of the other provisions of the Fifth Articles of Restatement to the Articles of Incorporation remain in full force and effect.
