ARTICLE I. NAME

The name of the ostrich farm corporation is Supreme Ostrich Farm, Inc.

ARTICLE II. PRINCIPLE OFFICE

ARTICLE III. PURPOSE

The ostrich farm corporation is formed to engage in every phase and aspect of raising, processing, packaging and delivery of ostrich meats and hides.
