Article I

Name. The name of this Corporation is HANDI-HOUSE OF NORTH CENTRAL FLORIDA, INC., and the principal office address of the corporation is 1670 S. Walnut Street, Starke, Florida 32091.

Article II

Initial Registered Office and Agent. The street address of the initial registered office of this Corporation is 303 State Road 26, Melrose, Putnam County, Florida, 32666 and the name of the initial registered agent of this Corporation is JOHN D. MIDDLETON.

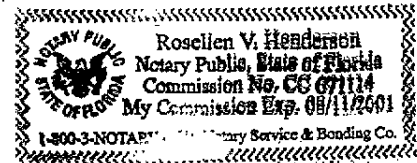

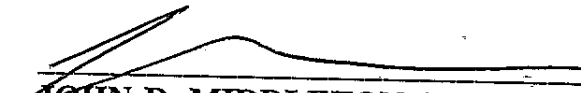
