

**ARTICLES OF INCORPORATION**

The undersigned subscribers, Dora Ortiz, Daniel Ortiz and Aristides Maradiaga, competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the proposed corporation is: Superior Painting, Inc.

**ARTICLE II**

The corporation may engage in any activity or business permitted under the laws of the United States of America and the state of Florida.

**ARTICLE III**

The total number of shares of stock which the corporation shall have authority to issue is 100 shares at a par value of \$1.00 per share.




