The undersigned incorporators, for the purposes of forming a corporation under the Florida Business Corporations Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE ONE
NAME AND PRINCIPAL ADDRESS

The name of the corporation shall be **DATA TECH COMPUTER SERVICES, INC.** The Principal address of the Corporation will be **87 NE 44TH STREET, #8, FORT LAUDERDALE, FL 33334.**

ARTICLE TWO
DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.



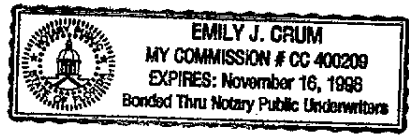
