ARTICLES OF INCORPORATION

IN COMPLIANCE WITH THE REQUIREMENTS OF FLORIDA STATUTES CHAPTED OF THE UNDERSIGNED, BEING A NATURAL PERSON DOES HEREBY ACT AS AN INCORPORATION ADOPTING AND FILING THE FOLLOWING ARTICLES OF INCORPORATION FOR THE URPOSE OF ORGANIZING A BUSINESS CORPORATION.

ARTICLE I. NAME

THE NAME OF THIS CORPORATION SHALL BE: MASTER MECHANICS OF CAPE CORAL, INC.

ARTICLE II. COMMENCEMENT & DURATION
