The undersigned subscriber, she being a natural person, competent to contract for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation for such corporation.

**ARTICLE I**

**NAME OF BUSINESS:** The name of the proposed corporation shall be **LIFESOURCE PRODUCTS, INC.**

**ARTICLE II**

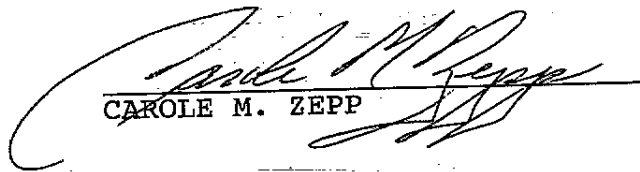
