AMENDMENT ARTICLE IX

These Articles of Incorporation may be amended in the manner provided by law. LIMITATIONS ON CORPORATE STOCK ARTICLE X

- 3. No shareholder of the Corporation may sell or transfer his stock in this corporation except to another individual who is eligible to be a shareholder of the corporation.

DISSOLUTION ARTICLE XII
