ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME

Section 1.1 <u>Name</u>. The name of the corporation is SOUTH CLAY MEDICAL ASSOCIATES, INC.

ARTICLE II

DURATION

Section 2.1 <u>Duration</u>. The corporation shall exist perpetually. CAPITAL STOCK

- Section 4.1 <u>Authorized Capital.</u> The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share. Said authorized shares may be divided into voting and non-voting shares before issuance by action of the Board of Directors; provided, however, that in the event such designation is not specifically made by the Board of Directors, said stock shall be deemed voting.
