FIRST: Amendment adopted:

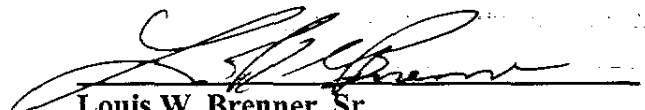
ARTICLE I is hereby amended as follows:

SECOND: The date of the amendment's adoption is: March 31, 2003.

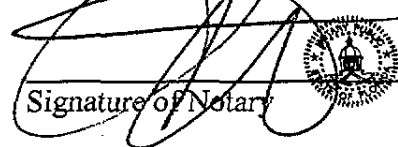
