**ARTICLES OF INCORPORATION
OF
Cantonment Two, Inc.**

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is Cantonment Two, Inc. and the mailing address of this corporation 516 Lakeview Road, Unit 8, Clearwater, FL 33756.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
