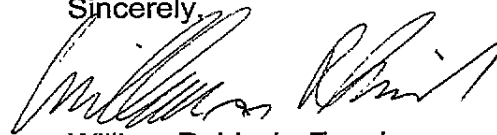

OF

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is COMPLETE ACCESS, INC..

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be conducted and created by this corporation is to provide for wall cover plates and all other related business in which a corporation is lawfully authorized to engage in the State of Florida.

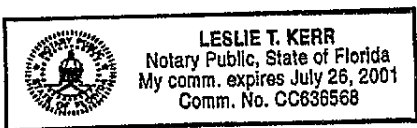

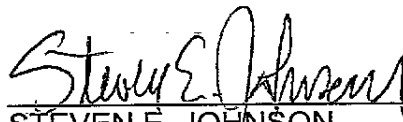
