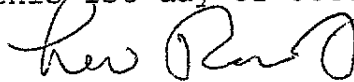
ARTICLE VI

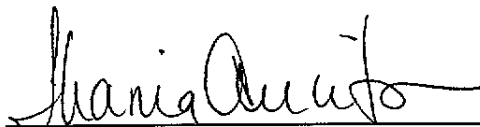

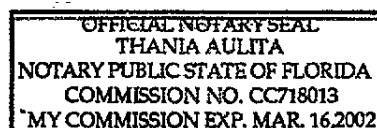

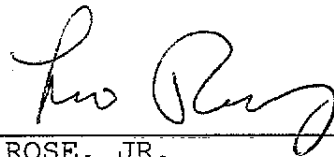
