ARTICLE ONE - NAME

The name of this corporation is: SWF East, Inc.

ARTICLE TWO - DURATION; EFFECTIVE DATE

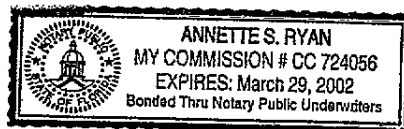

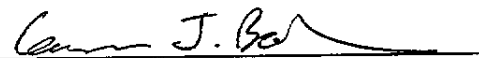
