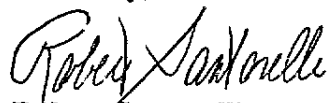

ARTICLE I

NAME

The name of this corporation is **BRETT GARCIA, INC.**

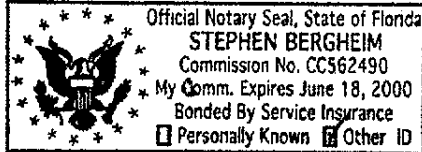
