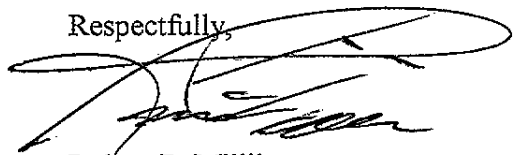

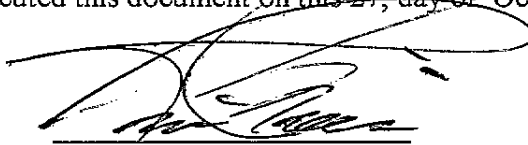

1. **Name.** The name of the corporation is: Bob's Citgo, Incorporated
2. **Purpose.** The corporation may engage in any legal business.
3. **Stock.** The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share. 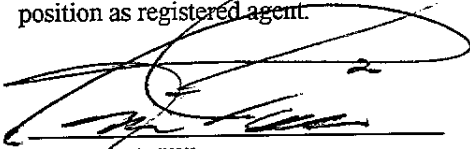
