**ARTICLE I - CORPORATE NAME**

The name of this corporation is TRICORB, INC., whose principal office and mailing address is 3702 Shenango Place, Melbourne, Florida 32934.

**ARTICLE II - NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III - CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 2,500 shares of common stock having a par value of One Dollar (\$1.00) per share.
