

ARTICLES OF INCORPORATION OF ALLIED CHASE RETAIL, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is ALLIED CHASE RETAIL, INC.

ARTICLE II-PRINCIPAL OFFICE

ARTICLE X-AMENDMENT


