ARTICLES OF INCORPORATION OF MAHARLIKA SHIP SUPPLY CORPORATION

THE UNDERSIGNED has executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE 1.

The name of this corporation shall be:

ARTICLE 2.

The physical and mailing address of the principal office of the corporation

The effective date of this corporation shall <u>January 1, 1999</u>, at which time it shall commence existence. The corporation shall have perpetual existence thereafter.
