- 1. This Statement of Fact is given on the basis that the Affiant has personal knowledge pertaining to A.W.P.O.V. RUG SPECIALISTS, INC., a Florida for-profit corporation, whose taxpayer identification number is 59-3544524, and whose Florida Secretary of State Division of Corporations Document Number is P98000099045 (the "Company"), and its internal dealings and operations.
 - 2. I am the original incorporator of this Company and founded it on November 18, 1998.
- At no time have I sold the Company or authorized any other individuals to act on behalf of the Company.
- 4. I am the sole owner of the Company, who owns one hundred percent (100%) of the Company's shares.
- 5. I filed an Annual Report on February 2, 2023, listing myself as Registered Agent and as President and Owner of the Company. This information is consistent with the historical Annual Reports on file with the Secretary of State.
- 6. The Annual Report dated February 9, 2023 (Filing Number: 6316368116CC) filed by Mary Louise Sampson naming herself as the President and Owner, and listing herself as Registered Agent, is fraudulent and was filed without authorization or knowledge of the Company.
- 7. The Annual Report dated January 31, 2024 (Filing Number: 4910313078CC), filed by Mitchell Damico, as registered agent, listing himself as President, and Mary Louise Sampson as Vice President is fraudulent and was filed without authorization or knowledge of the Company.

8. Filing Number: 6316368116CC and Filing Number: 4910313078CC (collectively, the Fraudulent Filings) have no basis in fact, and the people referenced therein are in no way authorized

representatives or agents of the Company, and they have no affiliation with the Company whatsoever.

9. At no time has Mitchell Damico or Mary Louise Sampson (the "Unauthorized Parties") ever had an ownership interest in the Company, and at no time has either been a director, officer, or registered

agent of the Company.

10. This Statement of Fact is given to provide notice that the Unauthorized Parties fraudulently

removed Affiant, the Company's true owner, and fraudulently replaced Affiant, naming the Unauthorized

Parties as registered agent, president and vice president of the Company on February 9, 2023 and again on

January 31, 2024, without authorization to act on behalf of the Company.
