## ARTICLES OF INCORPORATION OF STORM SURGE PRODUCTIONS, INC.

38 MOV 25 11 0 26

The undersigned, for the purpose of forming a corporation, for profit, files these Articles of Incorporation with the Secretary of State of the State of Florida, pursuant to the Florida Business Corporation Act of the State of Florida, Chapter 607, Florida Statutes.

- 1. <u>NAME</u>. The name of the corporation is Storm Surge Productions, Inc. (the "Corporation").
- 2. <u>ADDRESS</u>. The street address and the mailing address of the initial principal office of the Corporation is 3910 W. San Pedro St., Tampa, FL 33629.
- 3. <u>NUMBER OF SHARES</u>. The maximum number of shares which the Corporation is authorized to issue is 7,500 shares of common stock, having no par value per share.
