ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "SAFETY Smart, Inc." The principal location of the corporation is 54 Mayfield Circle, Ormond Beach FL 32174.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of safety and risk management consultant work and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK
