ARTICLE VIII

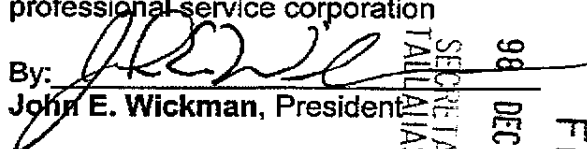
