**ARTICLE II - DURATION**

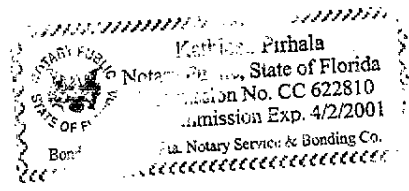

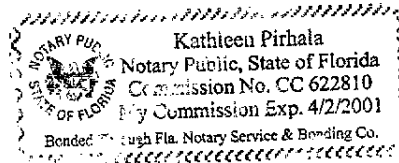
