ARTICLES OF AMENDMENT OF
BW SARASOTA, INC.

THE UNDERSIGNED, THOMAS WATERS and KERI A. BATTAGLIA, being the Directors and Shareholders, of BW SARASOTA, INC., do hereby certify that the following Amendment to the Articles of Incorporation of BW SARASOTA, INC. was approved by the Stockholders of said Corporation on the 14th day of November, 2000, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of BW SARASOTA, INC. are hereby amended as follows:

1. Article I is hereby deleted and the following is inserted in lieu thereof:

ARTICLE I - NAME


3. This Amendment has been approved by unanimous consent of all of the Shareholders of the Corporation who are entitled to vote.




