ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Professional Service Corporation and Limited Liability Company Act and the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

Article 2. Mailing Address. The mailing address of the Corporation is:

Article 3. Duration. The duration of the Corporation is perpetual.

Article 4. Purpose. The purpose of the Corporation is to provide medical services to the public and other related professional services permitted by Florida law.

Article 5. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class and shall have \$0.10 par value. The issuance of any shares shall be restricted to persons who are licensed to provide medical services.

Article 7. Incorporator. The name and address of the Incorporator is as follows:



In accordance with Section 607.0203, Florida Statutes, the date when corporate existence shall commence shall be January 1, 1999, unless these Articles of Incorporation are filed after such date, in which case the date when corporate existence shall commence is the date of filing by the Secretary of State.


