**ARTICLE 1. - NAME**

The name of the corporation is **YAEGERS FINANCIAL SERVICES, INC.**

**ARTICLE 2. - PRINCIPAL OFFICE**

The principal office of the corporation shall initially be at 1901 Baywood Court, Sarasota, Florida 34231. The corporation may change its principal office from time to time as permitted by law.

**ARTICLE 3. - MAILING ADDRESS**

**ARTICLE 4. - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE 5. - EFFECTIVE DATE OF INCORPORATION AND DURATION**

This corporation shall commence its corporate existence effective January 1, 1999 and this corporation shall exist perpetually thereafter until dissolved according to law.
