#### ARTICLES OF INCORPORATION

OF

GOLD STAR AVIATION & ACCESSORIES, INC.

The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

#### ARTICLE 1. - NAME

The name of this corporation is:

GOLD STAR AVIATION & ACCESSORIES, INC.

#### ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in all aspects of repairing, rebuilding & maintaining aircraft engines & all peripheral parts to the the engine, to buy rebuild & sell aircraft engines & parts and to engage in any and all functions, services and/or activities determined as necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
- (b) To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description.
- (c) To conduct business in, have one or more officers in, and buy hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patent, copyrights trademarks, and licenses in the State of Florida, and in all other states, districts, territories, contries and colonies.
