ARTICLE I

The name of the corporation shall be **ALICE REITER FELD, P.A.**, and its mailing address shall be 7437 Northwest 57th Street, Tamarac, Florida 33319.

ARTICLE II

This corporation shall begin its existence commencing immediately in January 1999. Its existence shall be perpetual unless or until it is dissolved on a vote of the shareholders as provided in these Articles or unless or until it is dissolved by action of law.

ARTICLE III

The purpose of the Corporation is to practice the profession of law. The sole and exclusive professional services to be rendered by the Corporation are legal services.

ARTICLE IV

The Corporation shall have all the rights and powers now or subsequently conferred upon professional corporations by the laws of the State of Florida including but not limited to the following listed powers. The Corporation shall have the power to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments, and shall also have the power to own, lease, or otherwise use real or personal property necessary for the rendering of its professional services.

ARTICLE V

The Corporation shall have authority to issue 1000 shares of common stock of \$1.00 per value which shall be designated "Common Shares".

ARTICLE VI

Every shareholder, upon the sale for cash of any new stock of the Corporation shall have the right to purchase his/her prorated share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII

The address of the initial registered agent of this corporation shall be 7437 Northwest 57th Street, Tamarac, Florida 33319 and the name of the initial registered agent shall be **ALICE REITER FELD**.

This corporation shall indemnify any officer or director, to the full extent permitted by law.

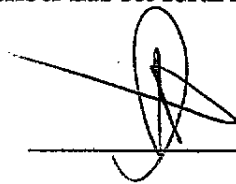
ARTICLE XI
