CERTIFICATE OF INCORPORATION

ARTICLE I

NAME

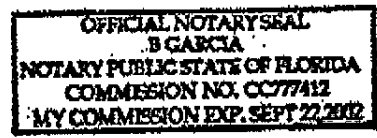




