Please be advised that we filed the annual report on 4/20/11, printed the payment voucher and sent the check out on 4/21/11 with approximately 40 other checks.

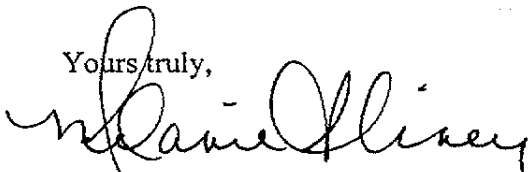
Upon receiving your notice today we checked with our bank and were advised that the check has not cleared.
