The undersigned, acting as incorporators of Adams of Adams of Incorporation:

ARTICLE I

The name of the corporation shall be DECO DESIGNS, INC.

ARTICLE II

The corporation shall exist perpetually and for an indefinite period, commencing on the 1st day of January, 1999.

ARTICLE III

This corporation is authorized for the purpose of transacting any and all lawful business permitted under the laws of the United States and the State of Florida.


