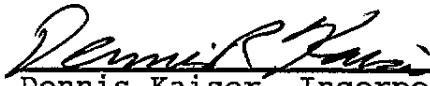
ARTICLE VI

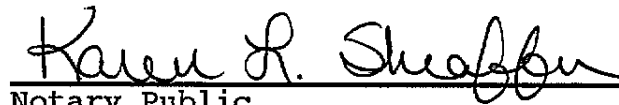

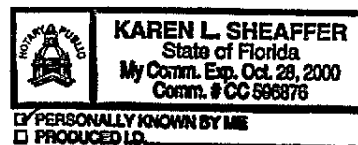
