The undersigned incorporator, a natural person competent to contract, hereby adopts the following Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes, the Florida Business Corporation Act.

**ARTICLE I**

**NAME**

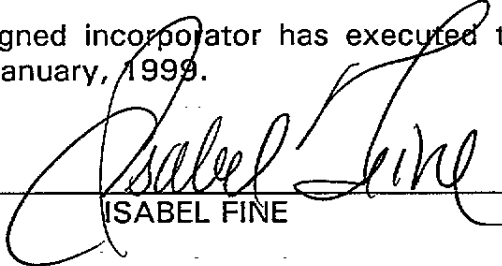

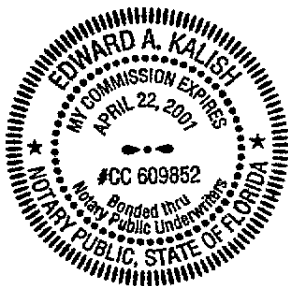

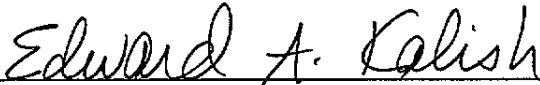
