
ARTICLE VIII



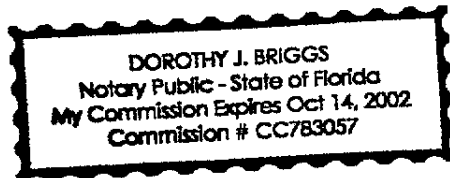
