
ARTICLE VIII

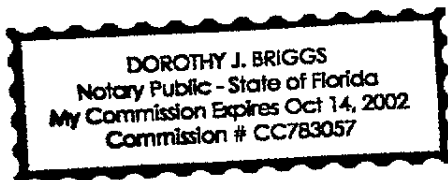
