

# ARTICLES OF INCORPORATION OF SOUTHEAST DEVELOPMENT ASSOCIATES, INC.



#### ARTICLE I - NAME

The name of this Corporation is SouthEast Development Associates, Inc.

## ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
