The undersigned incorporator hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE I, NAME

The name of the corporation shall be BREVARD ACUPUNCTURE, P.A...

ARTICLE II, NATURE OF BUSINESS

This corporation may provide acupuncture and herbal medicine services to the general public pursuant to Florida Law.

ARTICLE III, CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1.00 par value per share.


