This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

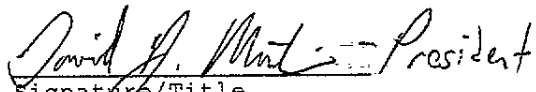
ARTICLE IX - INDEMNIFICATION

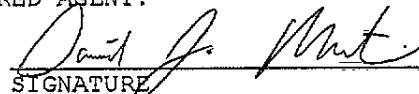
