**ARTICLES OF INCORPORATION  
OF  
WARLOW DEVELOPMENT, INC.**

The undersigned hereby makes and subscribes these Articles of Incorporation intending to form a corporation under the provisions of Chapter 607, Florida Statutes.

**ARTICLE I – NAME**

The name of this corporation is WARLOW DEVELOPMENT, INC.

**ARTICLE II – PURPOSE**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida. While engaging in such activity or business, it may exercise all of the powers and privileges conferred by Chapter 607, Florida Statutes, as presently in effect as it may be amended from time to time in the future.

**ARTICLE III – CAPITAL STOCK**

The corporation is authorized to issue ten thousand (10,000) shares of common stock, each share having a par value of \$1.00.

**ARTICLE IV – DURATION**

The corporation is to have perpetual existence, beginning in accordance with law.

**ARTICLE V – INITIAL REGISTERED OFFICE AND AGENT**
