## ARTICLES OF INCORPORATION OF SUNLIFE OB/GYN SERVICES OF FT. LAUDERDALE, P.A.

The undersigned incorporator does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a professional corporation under the Florida Professional Corporation Act:

- 1. The name of the Corporation is Sunlife OB/GYN Services of Ft. Lauderdale, P.A.
