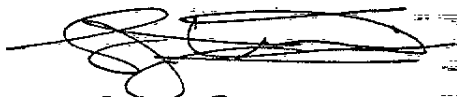

Name

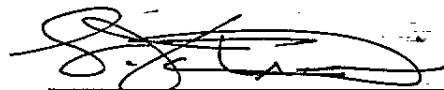
**Article 9**

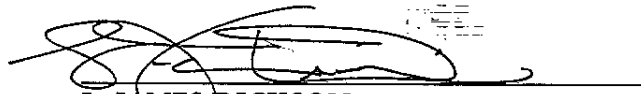
