The undersigned acting as incorporator of a Corporation pursuant to Chapter 607, Florida Statutes, hereby files these Articles of Incorporation in order to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

Name

The name of the corporation shall be:
GOLDCOAST PROPERTY INVESTMENTS , INC.

ARTICLE II

Powers

I. The Corporation's purposes as herein stated shall be carried out by its Board of Directors in a manner that will enable the Corporation to comply with Chapter 607, Florida Statutes. To this end the Corporation shall have all powers enumerated under Chapter 607, including but not limited to the power:

- A. To own, acquire, convey, exchange, lease, mortgage, encumber, transfer in trust, or otherwise dispose of all property, real or personal; to borrow money, contract debts, and issue bonds, notes and debentures, and to secure the payment of performance of its obligations.
- B. To receive property by gift, devise or bequest subject to the laws regulating the transfer of property by will, and otherwise to acquire and hold all property, real or personal, including shares of stock, bonds and securities of other corporations.

- C. To enter into contracts with any person, firm, association, corporation, municipality, county, state, nation or other body politic or with any colony, dependency or agency of the foregoing.
- D. To perform every act necessary and proper for the accomplishment of the objects and purposes enumerated, or otherwise allowable under Chapter 607, of Florida Statutes, and/or for the protection and benefit of the Corporation.

ARTICLE III

Shares

The Corporation shall be authorized to create and issue *one-thousand (1,000)* Shares of Common Stock.

ARTICLE IV

Term of Corporate Existence

This Corporation shall exist perpetually unless dissolved according to law.

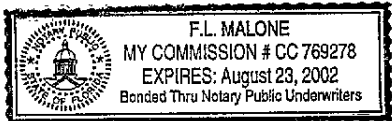


