# ARTICLES OF INCORPORATION OF CORAL ELECTRIC OF THE KEYS, INC

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I

The name of the corporation is Coral Electric of the Keys, Inc.

# ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United State of America and the State of Florida.

#### ARTICLE III

The corporation is authorized to have outstanding one class of stock designated as common stock. The maximum number of shares of common stock which the corporation is authorized to have outstanding is five hundred (500) shares at a par value of one dollar (\$1.00) per share. Holders of the common stock are entitled to vote on all questions required buy law not he basis of one vote per share and there shall be no cumulative voting. Holders of common stock shall not have pre-emptive rights to subscribe to the corporation securities.

#### ARTICLE IV

The amount of capital with which the corporation shall begin business shall not be less than five hundred dollars (\$500.00).

#### ARTICLE V

The corporation shall have perpetual existence.

#### ARTICLE VI

The initial street address of the principal office of the corporation in the State of Florida is 5 Oakwood Avenue, Key Largo, FL 33037. The Board of Directors may, from time to time, move the principal office to any other address.

#### ARTICLE VII

The corporation shall have one (2) directors initially. The number of directors may be increased or diminished from time to time by the By-Laws adopted by the stockholders, but there shall always be at least one (2) directors.

To the extent permitted by the law, the corporation shall indemnify and hold harmless each person who shall serve as a director of the corporation as a director or officer of any corporation, from and against any and all claims and liabilities to which such person shall become subject by reason any action alleged to have been taken or omitted by him as a director or officer. The corporation shall reimburse each such person for all costs, legal and other expenses reasonably incurred by him in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable to the extent permitted by law.
