

ARTICLES OF INCORPORATION OF MISA, INC.



The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Business Corporations Act.

ARTICLE I Name of Corporation

The name of the corporation is:

MISA, INC.

ARTICLE II Commencement of Business

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.
