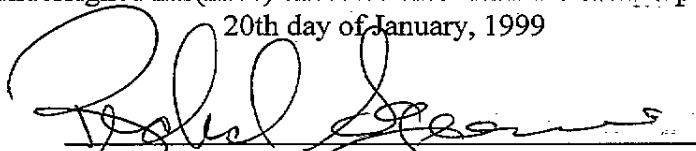

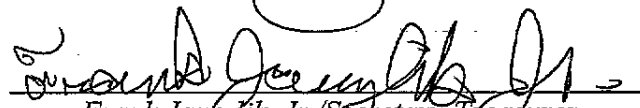

1. No person shall be required to own, hold, or control stock in the corporation as a condition precedent to holding an office in this corporation.

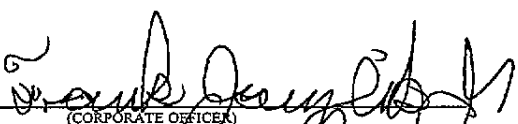
