**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a business corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 100,000 shares of common stock having a par value of \$1.00 per share.


