ARTICLE I - Name

The name of the corporation shall be:

A JOB WELL DONE JANITORIAL SERVICE, INC.

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following:

Janitorial/Cleaning, and related services.

ARTICLE IV - Capital Stock

This corporation is authorized to issue One Thousand (1,000) shares of Ten Cents (.10) par value common stock which shall be designated "Common Shares".

ARTICLE V - Preemptive Rights
