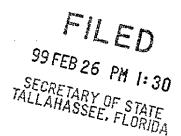

ARTICLES OF INCORPORATION OF Fine/AAA Interair, Inc.



ARTICLE I

The name of the corporation is Fine/AAA Interair, Inc.
