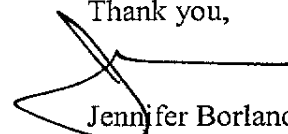

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is Fine/AAA Interair, Inc.
2. The following Amendment to the Articles of Incorporation was adopted by the unanimous written consent of the Board of Directors and Shareholders of the Corporation, the number of votes being sufficient for approval, as of October 15, 2002 in the manner prescribed by Section 607.1003 of the Act.
3. Article I of Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article I as follows:

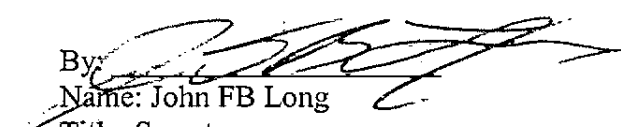
ARTICLE I
